Product Transition: 3M Badge Monitors

Dear Valued Customer:

We would like to inform you of some upcoming changes to the 3M diffusion monitor product line to help ensure the products you are using offer the best in terms of availability and performance for the long term.

3M is discontinuing the 3M™ Organic Vapor Monitor 3500/3510 & 3520/3530, 3M™ Ethylene Oxide Monitor 3550/3551 and 3M™ Formaldehyde Monitor 3720/3721 **as of March 31, 2021**.

3M will replace the discontinued diffusion monitors with a line of new diffusion monitors to meet customer needs. **Orders received on or before March 31, 2021 will be fulfilled until inventory is depleted. After that time, all outstanding orders will be cancelled and will need to be placed utilizing the new products highlighted below.**

ORGANIC VAPOR MONITORS

The 3500+/3510+ monitors are versatile organic vapor monitors and can be used for applications in which either the 3500/3510 monitors or 3520/3530 monitors had been used previously, unless very low detection limits are required.

The 3501+/3511+ monitors add a new capability to the 3M monitors line, as they have higher sampling rates and thus are more applicable for lower detection limits or short-term sampling.
